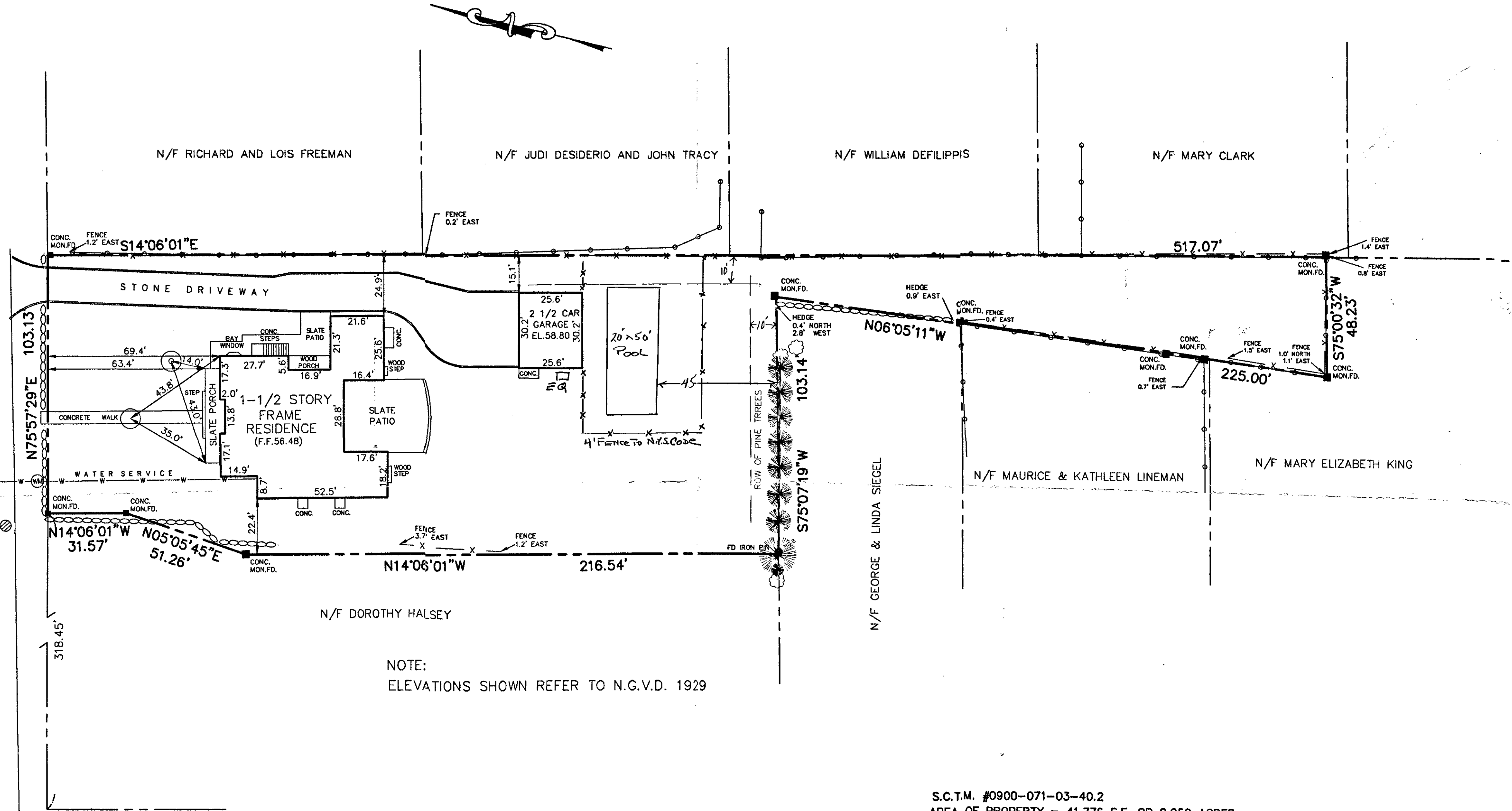


EDGEWOOD AVENUE (SAWASETT AVENUE)

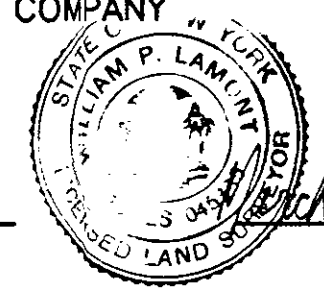
